Due to its bulk, height and width, as well as its position set back only a small distance from the existing house frontage, the proposed two storey side extension was not sufficiently subservient to the main dwelling house and also overbearing as regards the neighbouring property Sandymount. It also unacceptably closed up the gap between Ryecroft and Sandymount in this sensitive location on the edge of the village settlement, thereby obscuring the view between the houses through to trees to the rear, thus having an adverse impact on the visual amenity afforded by the existing wide gaps between all the houses here in the "close" end of Surrey Gardens.
