## Minutes of the Meeting of the Parish Council held in the Club Room East Horsley Village Hall 2<sup>nd</sup> December 2024 at 7.30pm

- 94. To Receive and Accept Apologies for Absence in accordance with LGA 1972, Sch12, Para 40
- 1. Apologies received from Aileen Aitcheson
- 95. Declaration of Disclosable Pecuniary Interests (DPI's) by Councillors on any of the agenda items below in accordance with The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 and any Non-Pecuniary Interests in accordance with the Parish Council's Code of Conduct
- 2. None
- 96. To Agree and Sign the Minutes of the Previous Meeting held on the 13th October 2024
- 3. The minutes of the previous meetings were agreed as an accurate record. The Chair signed them. **Chair's Comments**
- 4. The Chairman commented that the new road to Wisley Gardens was now open.
- 5. A stock of local history books have been received from HCPS. A selection of these have been given to councillors there are still some available.

#### 97. SCC and GBC Update

- 6. GBC Cllr. Catherine Young told the meeting that SCC Highways are considering options for improving road safety on A246, it is hoped this will include a reduction in the maximum speed.
- 7. Catherine confirmed that the licensing committee are reviewing street trading licensing following lobbying by EHPC councillors.

#### 98. Public Participation

- 8. A resident invited councillors to attend the Horsley Choral Group carol concert. Tickets are still available.
- 9. A resident was concerned about the pothole at the junction of Ockham Road South and Station Approach. The Clerk confirmed this would be repaired within 5 days.
- 10. A resident was appalled at the condition of Kingston Avenue telephone kiosk, they hoped something would be done soon.
- 11. A resident expressed concern at the recent extensive flooding in Kingston Avenue. The road was impassable for pedestrians and unwise for vehicles to drive through.

#### 99. Planning and Environment Matters

- 10. The Council reviewed the report on Planning & Environment Committee Meetings held since their previous council meeting, (Appendix 1)
- 11. In the preceding 11 months 81 applications have been reviewed, this is the lowest number since the PC started recording them.

#### 100. Financial Matters

- 11. The list of payments issued since the previous meeting were approved, total being £20129.34. (Appendix 2)
- 12, 2025-26 Budget, The council approved the budget presented by the Finance & Risk Committee.
- 13. The Q2 reconciliation and financial report were approved by the council.

#### 101. To Agree the Parish Office Rent

- 12. The Council approved the rent at £1727.94 a 1.5% increase on 2023-24.
- 13. The Parish Meeting Room is fixed until January 2026

#### 102. To Agree Staff Salary Increases

14. The National Joint Council for Local Government Services have agreed a 2.5% salary increase from April 2024. Increases are in line with staff contracts.

#### 103. To Agree Meeting Dates for 2025-26.

15. The council agreed the dates. These will be circulated to SCC and GBC councillors

#### 104. To Agree to Renewing Membership of Surrey Association of Local Councils

16. The fee for 2024-25 was £1484.68 this has increased to £1525.13 a 2.5% increase equivalent to 36.3 per elector. The council approved this increase.

#### 105. To Agree to Expenditure on Traffic Speed Surveys

17. The council recognised the importance of collecting speed date on the main roads of the village. The council agreed to fund 20 surveys costing £3400.

#### 106. To Agree to Forming a New Task Group

18. The council agreed to form a Community, Communications and Events Group. This will amalgamate three task groups previously run as separate groups. Allotments will be managed by the Clerk.

#### 107. To Discuss the Chairmans Christmas Party

19. A time line for the event was circulated.

#### 108. To Discuss the Christmas Window Competition

20. The Mayor of Guildford will judge the retailers windows in the village on Tuesday 3<sup>rd</sup> December. The shield will be presented to the winner at the Chairman's Thankyou Party.

#### 109. To Discuss Ideas for the Annual Parish Meeting

21. It was agreed to hold the event in the Village Hall on 13<sup>th</sup> May 2025. Councillors were asked to consider appropriate topics.

#### 110. Horsley Station Display Board

22. A sample of the display board was presented to the meeting. Councillors were asked to review the A4 copies they were given by 13<sup>th</sup> December for final sign off in the new year.

#### 111. The Repair Café Update

23. The November meeting had the highest level of attendees. Since launch in July 24 100 items have been repaired this is a great outcome for the owners and environment.

#### 112. Task Group Progress Reports

- 24. Climate Change (Sylvia Igglesden) Advised next meeting of the group is Wednesday 4<sup>th</sup> December.
- 25. Communications (*Steve Harvey*) The Winter Newsletter has been printed and will be available on 12<sup>th</sup> December to coincide with the Chairman's Party.
- 26. Community (Holly Haling) The Christmas event will be held on 7<sup>th</sup> December at Station Parade. Two of the planned self defence classes have been held, they were both sold out.
- 27. Countryside (*Juliet Robinson*) On 29<sup>th</sup> November volunteers helped plant 200 hedging plants at Wellington Meadow. A work party cleared some of the arisings left from the recent Wellington Meadow cut on Friday 21<sup>st</sup> November. The council is grateful to all volunteers. The group is challenging Surrey education department regarding their proposed 'Safe Walking Route' through Great Ridings Wood to Effingham.
- 28. Events (Steve Harvey) Planning for the Big Day Out on 29<sup>th</sup> June 2025 has started. This event will partner with the Sam Beare Hospice
- 29. Railway (*Andrew Franklin*) Notes from the recent meeting have been circulated. Plans are being made to celebrate several milestones in the development of rail travel to East Horsley. A provisional date of 12<sup>th</sup> April is proposed.
- 30. Road Safety and Maintenance (*Andrew Franklin*) Work to raise the crown of trees at Park Horsley. This has made a significant improvement for residents sight lines looking west,
- 31. Village Appearance (*Aileen Aitcheson*) The Christmas lights are being installed and will be on for the Station Parade Event and Late night shopping at Bishopsmead Parade..
- 32. Horsley Heritage Group(*Robert Taylor*) A number of local history books have been presented to councillors. More books are available. The proposed Blue Plaque scheme has been held up by the requirement to apply for listed building consent.

#### 113. Project Groups Significant Update Report

33. The Padel Tennis project has received three tenders for construction. Meetings have also been held with third party providers A questionnaire has been circulated to residents to gather opinions on the proposal. To date there have been 343 responses with 80% in favour.
