#### Reasons:

We have previously set out detailed objections to this application in our letter dated 1<sup>st</sup> May 2024. Although some design changes are now being put forwarded in the planning variations recently submitted, they do not address the fundamental issues we have raised in that letter. Our reasons for objecting therefore remain as follows:

- a) The development fails to respect the transitional character of the settlement edge in a particularly sensitive location;
- b) There is a failure to comply with GBC Local Plan requirements on backland developments;
- c) There will be an adverse impact on local road safety unless addressed by new interventions including the creation of a safe pedestrian crossing over the A246;
- d) There will be an adverse impact on local residential amenity.
